

Group Study Exchange District Application for program year 2006-07

Application for District _____

The Group Study Exchange (GSE) program provides travel grants to paired Rotary districts in different countries to exchange teams composed of four to six non-Rotarian professionals (ages 25-40) and a Rotarian team leader. Team members live in local Rotarians' homes wherever possible and follow a carefully prepared itinerary throughout the host district. Team members study and observe their host country's professional, commercial, and industrial operations; systems of government; and education, health, welfare, and social institutions.

Important

- Districts in good standing may apply for a World Fund Award to send one GSE team every year, regardless of the district's contributions to the Foundation.
- Group Study Exchanges may be carried out in one program year, both sending and receiving a team in the same year.
- World Fund Awards are not accumulable from year to year and cannot be donated to another district.

Additional GSE Award

In any program year, districts may opt to allocate District Designated Funds (DDF) through *SHARE* to cover the expenses of the exchange. The cost for one district to send a GSE team using DDF is US\$11,000 (or \$6,000 for a Neighboring Country GSE). Exchanges may be carried out in one program year, both sending and receiving a team in the same year.

Funding must be allocated in the *SHARE* system at the time the district applies to send a GSE team through DDF.

For further details on the *SHARE* cycle and various GSE options available, refer to the *District Rotary Foundation Committee Manual* (300-EN) or contact the *SHARE* system coordinator at The Rotary Foundation.

The Rotary Foundation Trustees make every effort to pair districts sending GSE teams through *SHARE*. However, if such a pairing is not possible, the appropriated DDF will be returned to your district's *SHARE* account for future use.

Districts may apply to send a maximum of two GSE teams per program year.

FINDING AN INTERNATIONAL PARTNER

Districts are encouraged to accept a pairing with any district selected by the Trustees. However, if your district wishes to arrange a pairing in advance, consider seeking a partner district that is culturally different from your own (e.g., high-income country vs. low-income country, or region where another language is spoken or customs may be significantly different). Or, consider a partner that is located in a geographic area that your district has not been paired with recently. Do not prearrange pairings until the governor of the exchange year(s) has been selected. This allows future district leadership to play a role in determining exchanges that will take place during their tenure.

When seeking a GSE partner:

- Consider your district's international service goals and objectives when identifying target districts.
- Consider districts with similar industries or social concerns (e.g., similar agricultural focus, or challenges of urban violence or public health).
- Send letters, faxes, or e-mails to potential partner districts, promoting points of cultural, geographical, historical, and vocational interest in your district.

CONDITIONS OF AWARD

In accepting this award, we understand and agree that:

1. The Rotary Foundation Trustees reserve the right to make final decisions on district pairings.
2. The district has appointed a GSE subcommittee of the district Rotary Foundation committee to administer the exchange, including promoting the program, identifying host families, creating a host itinerary according to GSE guidelines, and orienting the outbound team. The committee will be composed of at least three Rotarians on staggered terms with provision for continuity of membership.
3. The district has appointed a special GSE selection committee to select the team leader, team members, and alternates. The selection committee will include the current district governor, immediate past district governor, district governor-elect,

three Rotarians on staggered terms, and GSE subcommittee chair as chair of the selection committee. The selection committee will select team members who

- a) Are between the ages of 25 and 40
 - b) Have two years' experience in their field of work and intend to remain in the workforce for the foreseeable future
 - c) Are capable of having their long-term career paths impacted through the GSE experience
 - d) Are capable of sustaining the rigorous nature of a GSE
4. A team member must not be
- a) A Rotarian (includes Honorary Rotarian)
 - b) An employee of a club, district, or other Rotary entity, or Rotary International
 - c) A spouse, lineal descendant (child or grandchild by blood or legally adopted), or an ancestor (parent or grandparent by blood) of any person in a) or b) above
 - d) A spouse of another assigned team member
5. Spouses or other family of the team leader and team members may not accompany them during the tour under any circumstances.
6. The Foundation arranges and provides for only the cost of air travel for GSE team members and the team leader. The team must travel as a group from one point of departure in or nearest the sending district to one point of arrival in or nearest the host district.
7. The Foundation provides the most economical round-trip air ticket between the home and host countries, and the local Rotarians in the host area will provide meals, lodging, and group travel in their district.
8. Team participants must travel together in the host district throughout the study program. If a team member chooses to leave the team before the official end of the study tour, he/she may be responsible for the entire cost of the airfare. After the study tour, team members may travel in the host country or elsewhere at their own expense for no more than four weeks.
9. The district will arrange at least **five customized vocational study days per team member (approximately 20 vocational days per team of four non-Rotarian members)** to meet individually with representatives of his/her profession or a closely related profession to study related techniques, conditions, and levels of development, and to exchange ideas and information.
10. The district will provide free time of at least one full day and one half day each week, and one mid-tour break for the visiting team (no scheduled activities are to be included in this time).
11. The district shall defend, indemnify, and hold harmless Rotary International and The Rotary Foundation of Rotary International, their directors, officers, and employees from and against any liability, responsibility, costs, or obligations (beyond providing the cost of the team's transportation to and from the receiving district) based upon any negligent or unlawful act of the district or its representatives. The foregoing includes but is not limited to the team leader/member's vocational activities and services while in the host district.
12. Each above Condition of Award applies to all exchange awards granted by the Foundation Trustees. This includes any non-Rotary country GSEs requiring Trustee approval. All aspects of such awards, including travel arrangements and subsidies, will be administered per regular Trustee policy.

We understand and agree to the terms stated in the above Conditions of Award and that this application must be received by The Rotary Foundation no later than 1 October 2005 to receive a pairing for the 2006-07 program year.
